## Rules and Regulations

- 1) This Treasure Hunt is not a race and all traffic rules apply throughout the event. It will comprise a combined drive AND walk hunt lasting approximately at least four (4) hours.
- 2) Participating vehicles must be motorised and travel on 4 wheels (excluding pick-up trucks, lorries and buses) having road tax and insurance valid as at the day of the hunt.
- 3) At least **ONE (1)** member in each team must be a verified law graduate, an Advocate and Solicitor of the High Court of Malaya or Borneo, a pupil reading in Chambers, a member of the court staff of the State of Penang, the Attorney General's Chambers or the Judiciary. This member of the team **must** participate in the Hunt on the day of the Hunt unless excused by the organisers with valid reasons. The organisers reserve the right to require any proof of the qualification of the teams to their satisfaction.
- 4) Participants should have general good health and not suffer from any major illness which may reduce participants' abilities.
- 5) A team may consist of a minimum of 2 persons; being the Driver and a Navigator; with an option of no more than 2 additional team members.
- 6) The Driver and at least one other member in each team must possess a driving license valid for the duration of the Hunt.
- 7) The team not being disqualified and scoring the highest number of points less penalty points incurred will be declared the winner and all subsequent positions will be determined on the same basis. Tie-breakers in the event of a tie shall be as announced to the participants at the post-Hunt Briefing.
- 8) The decision of awarding points and prizes by the Clerk of the Course will be final.
- 9) Additional regulations, charges or information given at all Briefing sessions will be binding on all participants accordingly.
- 10) At least one team member from each team must attend the Registration and Briefing and he/she/they shall be responsible for disseminating all information provided at Briefing to all other team members. Kindly be informed that the Briefing will be held on the day of the Hunt itself at 8.00a.m.
- 11) Competition numbers or any car stickers provided by the Organisers shall be placed on participating vehicles as directed by the Organisers and must remain on the vehicles throughout the Hunt.
- 12) Entry pre-requisites:
  - a) All entries must be completed and the fees paid before it is officially accepted as an entry;
  - b) Entry Fees shall be RM60.00 per person – inclusive of a breakfast snack, Afternoon Tea at the venue, a Goodie Bag and a T-Shirt;
  - c) ALL team members must sign the Declaration on the Entry Form prior to submission. The Declaration must be signed by parents / guardians on behalf of team members who are minors. All minors are to be accompanied by parents / guardians in the team;
  - d) Entries will be limited to the first 50 teams on a-first-come-first-served basis at the discretion of the Penang Bar Committee;
  - e) Whilst all fairness will be exercised, the Penang Bar Committee reserve the right to reject any entry without explanation and return all monies paid; and

- f) The closing date for the receipt of entries is **Monday, 6.2.2012.**
- 13) Whilst every care will be taken, the Penang Bar Committee will not be held liable for any cheques or bank drafts lost in the post. Proof of mailing is not proof of receipt.
  - 14) The Penang Bar Committee reserves all rights to amend the rules/change or postpone the date/cancel the event if it is deemed needful.
  - 15) The participants hereby acknowledge that the Penang Bar Committee as the Organisers shall not be held responsible or liable for any accident, mishaps, loss, damages or liability suffered by the participants during the treasure hunt.
